






社会责任规划



公司概况

General Situation of Company

中国中铁是集勘察设计、施工安装、工业制造、房地 产开发及其他业务于一体的特大型企业集团,全球最 大的建筑工程承包商之一,在世界企业500强中排名第 86位,在中国企业500强中排名第8位。公司于2007年 12月3日、12月7日分别在上海、香港两地上市。公司 总资产6830亿元,净资产1090亿元。

中国中铁建设者先后修建了92540公里的铁路,占中 国铁路总里程的三分之二以上;建成电气化铁路接触 网70986公里,占中国电气化铁路的90%;参与建设的 公路超过16900公里,其中高速公路超过9773公里, 约占中国高速公路总里程的十分之一;参与建设了中 国五分之三的城市轨道工程;修建了武汉长江大桥、 南京长江大桥、东海大桥、杭州湾跨海特大桥等近万 座大桥, 总长达13184公里; 建成秦岭隧道、太行山隧 道、厦门翔安海底隧道、武汉长江隧道等长大隧道共 计10084公里。公司建设者12次远征南极,承担了中山 站、长城站、昆仑站建设和维护任务。公司还先后参 加了国内5000余项机场、码头、水电、高层建筑、市 政等大型工程的设计与施工,经营范围覆盖到土木建 筑的各个领域,工程项目遍布中国除台湾以外的各省 市自治区以及全球60多个国家和地区,科技水平在诸 多领域达到世界先进水平,多次获得国家最高奖项。

CREC is the extremely large enterprise group with survey and design, construction and installation, industrial manufacturing, real estate development and other business. It is the largest construction contractors in the world, ranking 86th in the top 500 companies in the world and 8th in the top 500 Chinese enterprises. Companies were listed respectively on December 3rd, 2007 and December 7th, 2007 in Shanghai and Hong Kong, with the total assets of RMB 683 billion Yuan and net assets of RMB 109 billion Yuan.

Constructers of CREC have successively built railways of 92540 kilometers, more than two-thirds of the total length of national railway; the electrified railway contacting net they have built reaches 70986 kilometers, accounting for 90% of national electrified railway. They are participated in the road covering over 16900 kilometers, of which expressway is more than 9773 kilometers, about one-tenth of high mileage. They are participated in the three-fifths of national urban rail project; they have constructed around 10000 bridges, including Wuhan Yangtze River Bridge, Nanjing Yangtze River Bridge, the East Sea Bridge, Hangzhou Bay Cross-sea Bridge, with the total length of 13184 kilometers. They have built long tunnels of Qinling Tunnel, Taihang tunnel, Xiamen Xiang'an undersea tunnel, Wuhan Yangtze River Tunnel and so on, with the total of 10084 kilometers. The builders with the Antarctic expedition for 12 times shouldered the construction and maintenance tasks of Zhongshan Station, Great Wall Station and Kunlun station. The company also has participated in more than 5000 items of airports, docks, hydropower, high-rise buildings, municipal and other large engineering design and construction, with the business scope covering all civil construction fields, and the projects in all provinces and autonomous regions of the nation apart from Taiwan and more than 60 countries and regions in the world. The technological level in many areas has reached the world's advanced level, and has won the national highest award for many

2014年,公司依法合规完成董事会、监事会换届工作。报告期末,公司董事会由7名董事组成,其中执行董事3名、独立非执行董事4名。董事会下设战略、薪酬与考核、审计、提名、安全健康环保5个专门委员会,其中战略委员会由5名董事组成,其中2名是独立非执行董事;审计委员会由3名董事组成且全部为独立非执行董事,其中2名是企业财务会计专业方面的专家;薪酬与考核委员会由3名独立非执行董事组成,均 具有业绩考核和薪酬管理经验;提名委员会由5名董事组成,其中3名是独立非执行董事;安全健康环保委员会由5名董事组成,其中3名是独立非执行董事。公司监事会由5名成员组成,其中股东代表监事2人,职工代表监事3人。公司高管层由8名成员组成,其中包括总裁1名,副总裁、总工程师1名,副总裁4名,财务总监1名,董事会秘书、总法律顾问1名。



Company Governance and Standardized Operation

Governance Structure

In 2014, the company has carried out term change of the board of directors and the board of supervisors according to laws and regulations. At the end of report period, the Board of Directors is composed of 7 members including 3 executive directors and 4 independent non-executive directors: there are 5 special committees of strategy, remuneration and performance, audit, nomination as well as safety, health and environment committees under the Board of Director, among which strategy committee is composed of 5 directors and two of them is independent non-executive director and: audit committee is composed of 3 directors, all of them are independent non-executivedirectors, and two of them are experts in enterprise financial accounting; nominations committee is composed of 5 directors and 3 of them are independent nonexecutivedirectors. SHE committee is composed of 5 directors, 3 of them are independent non-executivedirectors. The board of supervisors is composed of 5 members including 2 shareholder representative supervisors and three workers' representative supervisors. The upper management is composed of 8 members including 1 president,1 vice president and chief engineer, 4 vice presidents, 1 CFO, 1 secretary of the board and general counsel.

In 2014, CREC closely centered on the key points of state-owned assets reform and the new situation of enterprise reform and development, strictly followed the requirements of state-owned assets supervision and securities regulation and strengthened research and analysis of domestic and internationaleconomic situation, industry tendency and market environment. It not only improved the perspectiveness and scientificity of board decisions, but also further clarified the function orientation of the Board of Directors, the Board of Supervisors and management level, promoted the efficient connection between the Board of Directors and management level, reinforced mechanism construction of authorizationsystem and incentive constraint, optimized corporate governance structure of all levels, improved internal control management system and risk prevention and control system, expanded the communication channel of minority shareholders and regulation organizations, explored long-actingsupervisory mechanism of the Board of Supervisors and promoted delicacy management, reinforced executive construction, CREC has made remarkable achievements in comprehensive promotion of effective construction of corporate governance system, realization of shareholders' wills, protection of shareholders' benefit and promotion of sustainable and healthy development.



内控监督

中国中铁高度重视内控体系建设,按照《企业内部控制基本规范》要求,在制定下发《工程项目内部控制指导手册》等相关文件的基础上,2014年结合精细化管理工作继续深入推进工程项目内控体系建设和有效运行。加强内控缺陷整改,对内控审计和评价中发现的管理缺陷,进行了认真整改,修订完善了总部内部控制体系文件。召开管理制度评审会议11次,完成了55项规章制度的评审工作。

2014年,公司结合企业实际,在组织开展风险管理初始信息收集和所属各单位风险评估结果的 基础上,编制风险评估调查问卷,从5大类76个风险点列举出公司层面面临的风险,从风险发 生的可能性和影响程度两个维度制定风险评估准则,开展了风险问卷调查,评估确定公司层面 重大和重要风险,编制完成了《2014年度全面风险管理报告》。

Internal Control Monitoring

CREC attached great importance to construction of the internal control system. According to Basic Norms of Corporate Internal Control, by issuing relevant documents including Instruction Manual for Internal Control of Engineering Projects, in 2014, with the combination of delicacy management, CREC continued to deeply promote the construction and effective operation of inner control system of engineering projects. Moreover, the company strengthened efforts on defect rectification in internal control. With regard to management defects found in internal control audit and appraisal, the company took relevant rectification measures, revised and improved internal control system documents of the headquarter. In the whole year, management system appraisal meeting was held for 11 times. 55 rules and regulations have been appraised. Financial system internal control knowledge contents were held in the whole company.

In 2014, in combination with its reality and based on the organization and implementation of management initial information collection and risk assessment results of all subordinate units, the company compiled the risk assessment questionnaire, listed five categories 76 risk points that the company was facing, formulated risk assessment standards from the probability and influence degree of risk, carried out risk questionnaire survey, assessed and determined the great and major risks that the company was facing and compiled the Comprehensive Risk Management Report 2014.

我们的计算公式:

企业社会贡献值=盈利贡献+税费贡献+债息贡献+雇 员贡献+公益贡献+其他贡献-环境负贡献-安全质量负 贡献-其他负贡献。

每股社会贡献值=企业社会贡献值/总股本

近三年统计情况:

中国中铁2012年企业社会贡献值为1000.55亿元,每股 社会贡献值为4.69元。

中国中铁2013年企业社会贡献值为1187.5亿元,每股社 会贡献值为5.58元。

中国中铁2014年企业社会贡献值为1305.1亿元,每股社 会贡献值为6.13元。

Outstanding Contribution

Since 2008, we took the lead to disclose the value of a share of social contributions of the company in the industry. In 2014, we continued to improve the assessment system, researched and estimated the value of corporate social contribution value and one share value of the CREC in 2014 with the combination methods of self-statistics, estimation and expert assessments, just for your reference.

Our formula:

Corporate social contribution value = profit contribution + tax contribution + debt interest contribution+ employee contribution + the public welfare contribution + other contributions – negative contribution to the environment - negative contribution to the safety and quality - other negative contributions.

Each share of social contribution value = corporate social contribution value / total equity

The statistics in recent three years illustrated:

The corporate social contribution value of CREC in 2012 reached RMB 100.055 billion Yuan, and each share of social contribution value was RMB 4.69Yuan.

The corporate social contribution value of CREC in 2013 reached RMB 118.75 billion Yuan, and each share of social contribution value was RMB 5.58 Yuan.

The corporate social contribution value of CREC in 2014 reached RMB 130.51 billion Yuan, and each share of social contribution value was RMB 6.13Yuan.

- (5) Public welfare contribution: the direct expenditures of helping the poor, loving and others including donated money and things.
- (6) Other contribution: the positive benefits assessment value that corporate activities bring for the society except the above items listed.
- (7) The negative contribution to the environment: the value of corporate behaviors caused negative impact on the environment.
- (8) The negative contribution to the safety and quality: the value of corporate security quality incidents caused the negative impact on the society.
- (9) Other negative contribution: negative benefits assessment value that corporate activities bring to the society except the above items listed.



Leading Industrial Progress

As the main participator and promoter of the development of Chinese and world architecture, CREC has not only pursuit for self-development for many years, but also tasked the leading of industrial progress as its important responsibility, which mainly manifested in the expanding the industrial scale, driving the industrial self-discipline, leading technical innovation, win-win with partners and other aspects.

The company, as the first national "Innovative Enterprise" authorized by the Ministry of Science and Technology, the Stateowned Assets Supervision and Administration Commission and All China Federation of Trade Unions, owns 2 national laboratory "national engineering laboratory for Express Railway construction technology" and "national key laboratory for shielding and tunneling technology" as well as 7 postdoctoral centres. The company owns 7 nationally certificated technical centers and 21 provincially certificated technical centers, has successively set up 6 professional R&D centers and one BIM technology application and R&D center for bridge, tunnel, electrification, advanced engineering materials and measurement technique, rail and construction equipments. In 2014, after being included in "15 Key Contact Enterprises" of Outline of Implementation of Scientific Innovation Strategy among Central Enterprises of "the 12th Five-Year" Plan and "14 Pilot Enterprises" in study of technology innovation system construction strategies in central enterprises as the only central enterprise in the construction industry, "CREC Upgraded Projects of Technical Innovation System" won the 2nd Prize of National Scientific and Technological Progress Award under enterprise innovation engineering type. Being the first central enterprise of construction that won the Award since its establishment, it is proved that CREC is leading all central enterprises in the construction industry on technology innovation.

Information 1: by the end of 2014, the company successively has 697 scientific and technological achievements that have passed the provincial (department and municipality levels) identification of scientific and technological achievement; the company has totally 101 national science and technology progress awards and invention including 4 special prizes and 14 first prizes, and 2134 provincial and departmental (including prizes set by social forces recognized by the state) science and technology progress awards. The company owns 3996 valid patents including 712 patents for invention and totally achieved 91 national prizes for excellent project survey and design, 70 national prizes for excellent project survey and design and 152 provincial prizes for excellent project consultation achievements.



2014年,公司全面加强企业安全生产监督管理,进一步健全安全质量片区稽查队伍建设,实现工程项目安全质量常态化稽查。同时,全面组织和开展"四不两直"专项检查、半年度安全质量检查,有效监控了过程安全质量风险。

2014年,公司认真贯彻落实国务院安委会"六打六 治"的有关要求,在全公司分三个阶段集中开展了工 程项目"打非治违"专项行动,重点打击查处无资 质、超资质施工行为和工程违法转包、分包行为,整 治不良地质地段的施工安全问题,特别是不按规定进 行施工监控和质量检测的行为,整治邻近营业线影响 铁路运输安全的施工等问题。

资料1:2014年,中铁建工集团建立健全完善的安全 生产管理体系,夯实班组安全基础,充分发挥专职安 全员、群安员、青年安全岗的作用,强化安全质量全 过程监控,确保了安全质量处于有序可控状态,实现 "本质安全"。

资料2:2014年,中铁航空港进一步强化项目安全质 量管控,对公司所有在建项目开展安全质量稽查400多 次,共发现并消除重大安全质量隐患3处。

Implementation of Safeguard Measures


In 2014, the company reinforced safety supervision and management of the company, further improved construction of safety and quality instruction teams in each district and realized regular safety and quality inspection of engineering projects. Meanwhile, it organized and conducted "Four Nos and Two Straights" check and semi-annual safety quality check and effectively monitored safety quality risks during the process.

In 2014, the company seriously carried out related regulations of "Six Strikes and Six Punishments" required by National Security Commission and conducted "fighting against illegal production activities" special projects at three stages, especially non-qualified or under-qualified construction behaviors and illegal project subcontracting behaviors. It regulated construction safety issues at unfavorable geology sections, especially construction supervision and quality testing carried out not in accordance with the regulations. It also regulated construction issues near business lines that may interfere with railway transport safety.

Information 1: in 2014, CRCEG established sound safety production management system, enhanced team and group safety basis, brought professional safety officers, safety production supervisors and safety posts for youth into full play, strengthened safety quality process monitoring, ensured safety quality being in order and under control and realized "essential safety".

Information 2: in 2014, China Railway Airport Construction Group Co., Ltd. further strengthened project safety quality control and conducted more than 400 safety quality inspections on all project under construction. It has discovered and eliminated 3 major potential safety quality hazards.

加大安全教育

2014年,公司加大安全教育投入,利用报纸、网站、 宣传栏、下发光盘等媒介和手段,广泛开展安全生产宣 传教育。将竞赛答题活动与"安全生产月"和"一岗双 责"主题教育活动相结合,将教育培训内容与现场重大 危险源、施工进展及季节性安全管理相结合,掀起"学 安全,懂安全,会安全"的学习高潮。全公司所有重点 工程项目、施工现场、车间班组等生产一线,都设立了 统一的安全质量誓词牌,常态化开展"班前安全质量宣 誓"活动。2014年5月30日上午9时,全公司6000多个项 目经理部、约29万职工和近200万劳务作业人员同时开展 了安全质量宣誓活动。

资料1:2014年,中国中铁进一步强化安全质量专职人员的教育培训工作,先后举办了工程质量创优、注册安全工程师、建筑业和公路水运"三类人员"考核及继续教育等7期培训班,共计1100余名安全质量管理人员接受了培训。

资料2:2014年,中铁二局认真组织开展了百日安全、 安全生产月、安全生产警示日和专题活动周等一系列 安全生产教育主题活动,荣获2014年度四川省"安全 生产月"活动优秀组织单位。

Increase safety education

In 2014, the company increased investment in safety education. By using media and means such as newspapers, website, bulletin board and issuing CD, the company carried out safety production publicity and education extensively. It combined quiz activities with theme education activities of "Safety Production Month" and "two responsibilities for one post", combined education and training content with major hazard source management, construction process management and seasonal safety management and aroused enthusiasm of the personnel in learning centering on the goal of "learning, mastering and making full use of safety knowledge". Uniform safety and guality vow plates are set in all key projects, construction sites, workshops and other working units on the front line. The company held the activity of "making a vow of safe production before starting working" regularly.At 9 a.m. of May 30, 2014, more than 6000 project management teams, about 290,000 employees and almost 2 million operating personnel of the company were taking safety quality oath at the same time.

Information 1: In 2014, CREC further strengthened educational training of safety quality personnel and arranged 7 training sessions on project quality excellence, certified safety engineer and assessment and continuing education of personnel in construction, highway and water transport. A total member of 1100 safety quality management personnel received the training.

Information 2: In 2014, CREC No.2 organized and carried out a series of safety production education activities, including 100 day safety, safety production month, safety production warning day and special events' week. It was awarded excellent organizing unit of 2014 Sichuan "Safety Production Month" Event.

关注职业健康

2014年,中国中铁继续秉持"以人为本、安全发展" 的管理理念,强调"本质安全、长治久安",高度重 视员工身心健康。全公司进一步完善员工健康档案, 定期组织员工体检,为员工办理职业伤害保险,开展 健康讲座,引导员工和企业共同做好职业危害源头控 制,积极配合相关部门做好职业危害科学防治。持续 构建完善的培训体系、科学的激励体制和人性化的福 利制度,定期举行各类文体活动,促进员工不断成 长,保障员工身心健康。

在工程现场,加大资金投入力度,改善员工工作环 境,不断完善现场防尘、降噪及安全设施,加强作业 场所有毒有害气体、粉尘、噪声的检测和治理,为作 业人员提供符合安全卫生标准的劳动保护设施和个人 防护用品,最大程度地减少职业危害,积极为员工创 造安全、卫生、舒适、和谐的工作环境。

资料1:2014年,中国中铁深入贯彻落实国家《职业病防治法》等相关法律法规,宣传普及职业病防治知识,提高劳动者的职业病防治意识,共组织10万多人参加全国职业病防治知识竞赛,中铁三局、中铁四局、中铁六局、中铁八局、中铁九局、中铁十局、中铁电气化局、中铁二院8家单位荣获全国职业病防治知识竞赛活动优胜单位奖。

资料2:中铁六局按照年度职业健康目标要求,多措并 举强化管理,积极主动为作业人员提供符合安全卫生 标准的劳动保护设施和个人防护用品,所有施工作业 场所的有毒有害气体、粉尘、噪声的检测和治理均达 到国家和行业卫生标准,没有发生职业病案例。

Concerns about the Occupational Health

In 2014, CREC continued to adhere to the management concept of "people first and safe development", focused on "Intrinsic Safety and prolonged stability", highlighted the staff's physical and mental health. The whole company further improved the staff health archives, regularly organized staff physical examination and paid occupational injuries insurance for the staff. The company also held healthy lectures to lead the staff to control the source of occupational hazard jointly with the enterprise and actively coordinated with relevant departments to carry out the scientific prevention of occupational hazards. The company highlighted the personal growth and spiritual-cultural needs of the staff, constantly established and improved the training system, scientific motivation system, and humanized welfare system, regularly held all kinds of academic activities to promote the continuous growth.

On the construction site, the company continued to increase fund investment, improve staff's working conditions, constantly improve the site dustproof, noise reduction and safety facilities, enhanced the inspection and treatment of all noxious gas, dust, noise in the workshop, provided the personnel with working protection facilities and personal protecting materials to meet the safety and sanitation standards, maximally minimized the occupational hazards, and actively created the safe, clean, comfortable and harmonious working environment for the staff.

Information 1: In 2014, CREC thoroughly applied Law on Prevention and Control of Occupational Disease and other related laws and regulations, popularized prevention and treatment knowledge of occupational disease and raised laborers' awareness on prevention and control of occupational disease. It organized national knowledge contest on prevention and control of occupational disease with more than 100,000 participants. 8 units including CREC No.3, CREC No.4, CREC No.6, CREC No.8, CREC No.9, CREC No.10, CREC Railway Electrification Bureau and CREEGC were awarded national knowledge contest on prevention and control of occupational disease winning prize.

Information 2: According to the annual goal and requirement of occupational health, CREC No.6 took multiple measures to strengthen management and actively provided operating personnel with labor safety devices and personal protective devices that conform to safety and sanitation standard. Test and governance on hazardous gas, dust and noise of all construction workplaces have reached national and industrial sanitary standard and no case of occupational disease has been found.

节约能源物资

中国中铁严格贯彻执行能源管理体系标准(GB/T2331-2009)要求,坚持节约优先方针,秉承节约能源宗旨,把建立资源节约型、环境友好型企业作为目标,实行精细化管理推行"四节一环保"节能减排标准化工地建设,发展低碳经济,节能降耗取得成效。加大节能减排经费投入和技术攻关力度,推广应用节能减排技术和产品,发挥技术对节能减排的支撑作用,公司能效水平不断提高,圆满完成"十二五"阶段考核指标和国资委确定的2013-2015任期节能减排考核目标。公司31个项目获"全国建筑业绿色施工示范工程"称号。

资料1:2014年,全公司建筑企业万元营业收入综合能耗 同比下降5%左右,工业企业万元产值综合能耗同比下降 10%左右。全年全公司节能总计超过180万吨标煤。

资料2:中铁四局编制了《节能宣传手册》、《绿色 节能小百科》等书籍。持续开展"百元节约、千元增 效"主题实践活动,强化全员节能意识,实现每名员 工为企业节约100元以上成本,为企业增创1000元以上 效益的目标。2014年,中铁四局综合能耗比去年下降 2.78%。

Thrift of Energy Material

CREC strictly implemented the standards requirements of Energy Management System (GB/T2331-2009), insisted on energysaving prioritized policy, adhered to energy-saving purpose and took the establishment of energy saving and environmental friendly enterprise as the purpose. It carried out delicacy management and establishment of "Four Savings and One Environmental Protection" standardized energy conservation and emission reductionconstruction sites and achieved results in the development of low-carbon economy and energy-saving and cost-reducing. It also increased the financing investment in energy saving and emission reduction and technical tackle strength, promoted and applied energy saving and emission reduction technologies and products, as well as played the supporting role of technology in energy saving and emission reduction. The company's energy efficiency level has constantly enhanced and the enterprise has completed the assessment index during "the 12th Five-Year Plan" period and SASAC energy saving and emission reduction objective during 2013-2015. 31 projects of the company have won the title of "green construction demonstration project in national construction industry".

Information 1: In 2014, the comprehensive energy consumption per 10,000 Yuan operating revenue of construction enterprises of CREC decreased 5% on year-on-year basis, and the same of industrial enterprises decreased 10% on year-on-year basis. During the whole year, CREC has saved more than 1.8 million tons of standard coal.

Information 2: CREC No.4 compiled books such as Energy Saving Brochure and Encyclopedia of Green Energy Saving. It continued to carry out practical activities of "100 Yuan Cost Saving and 1000 Yuan Efficiency Improvement", which strengthened energy conservation awareness of all employees and achieved the goal that every employee saves cost worth over 100 Yuan and creates benefit worth over 1000 Yuan. In 2014, the comprehensive energy consumption of CREC No.4 was 2.78% lower than the previous year.

减少污染排放

2014年,公司环境保护取得成效,坚持保护优先,秉 承减少排放宗旨,采取防治结合措施。公司发布了《重 点节能低碳管理暂行办法》,鼓励各子、分公司研发和 推广应用新技术、新工艺和新设备,大大提高了能源 利用效率,降低了污染物的排放;同时加大了技术改 造和淘汰落后设备力度,减少了废气、废液的排放, 充分利用废渣等废弃物。工业企业推行绿色制造示范, 加大了技改力度,大力推行煤改气、电改气等节能技 术改造,废水、废气、固体废弃物(三废)综合治理 率达到 95%以上;"三废"排放达标率及固定锅炉废 气排放达标率达到 80%以上。2014年全公司节能减排 无重大违规违纪事件,排放污染物均达到国家和所在 地相应排放标准,圆满完成了国资委年度考核目标。

资料 1:中铁置业在项目开发中大力提倡绿色环保、低碳宜居,建立和完善了节能减排指标体系、监测体系和考核体系,所有在建项目均通过了地方行政主管部门的节能审查。

资料2:中铁科工集团的"旧水泥路面共振破碎再生 技术和关键设备的研制及推广应用"项目获得了中央 国有资本经营预算节能减排资金支持。该项目研制的 GZL600型共振破碎机被广泛应用到四川、上海、福 建等省份的公路及机场等"白改黑"改造施工工程中, 通过对旧水泥路面的共振破碎再生利用,大大降低了 我国水泥路面的重复性建设投入,起到了显著的节能 减排示范作用。

Reduction of Pollution Discharge

In 2014, the company has achieved results in environment protection. It insisted on the policy of protection priority, inherited the purpose of emission reduction and adopted the measure of combining prevention with treatment, thus environmental protection has been achieved. The company published Interim Procedures on Key Energy Conservation and Low Carbon Development, encouraged subsidiaries and branches to research, promote and apply new technologies, processes and equipments, greatly increased the efficiency of energy use and reduced the pollutant emission. At the same time, the company also increased the strength on technical renovation and elimination of the backward equipments, reduced the discharge of waste gas and wastewater and fully utilized the waste residue and others. The industrial enterprises increased the strength of technical renovation, and the comprehensive treatment rate of waste water, waste gas and solid waste (three wastes) have reached over 95%. The discharge standard rate of "three wastes" and fixed boiler waste gas discharge standard rate reached over 80%. In 2014, there was no environmental liability accident or great principle breach events on energy saving and emission reduction; the pollutant discharge reached both relevant national and local discharge standards and the company has successfully achieved the annual evaluation objectives assigned by SASAC.

Information 1: CRREG strongly advocated going green and environmental protection as well as low carbon and livable concept in project development. It established and improved index system, supervision system and assessment system of energy conservation and emission reduction; all of the projects under construction have passed energy conservation examination of local administrative departments.

Information 2: The project "development, popularization and application of technique and key equipment of old concrete pavement resonance breaking and regeneration" carried out by China Railway Science&Industry Group was supported by energy conservation and emissions reduction fund of state-owned capital management budget. The GZL600 Resonance Breaker developed by this project has been extensively applied to road, airport and "white to black" modification construction engineering projects in Sichuan, Shanghai and Fujian. By utilizing resonance breaking and regeneration of old concrete pavements, it greatly reduced repetitive construction input of concrete pavements and achieved significant result in energy conservation and emission reduction demonstration. **3** |

坚持环境治理

在环境治理方面,中国中铁把实现人与自然的和谐体 现在每一项工程中,建立了自上而下、全面监控的绿 色环保管理体系,积极做好生态环境的保护工作。公 司各项目部坚持"建优质工程,创文明生态"原则, 落实公司高标准的环境保护和水土保持措施,把"工 程质量和环保水保双优"作为奋斗目标,努力实现优 质工程与优美环境的高度和谐统一。

资料1:中铁一局积极发展污水处理等水务环保业务, 相继在兰州、银川、马鞍山投资成立了水务公司。其 中马鞍山中铁水务有限公司的日处理污水能力达10万 吨,承担了马鞍山市50%的污水减排量。

资料2:中铁五局高度重视拉日、贵广、杭长等开通运 营项目的环境治理,确保与周边环境融为一体。2014 年8月,组织西宁地区的130人开展了"清洁区域,美 化环境"义务劳动活动,共清理施工区域面积达2.2万 平方米,清理装运垃圾22车,共计660余吨。

资料3:中铁港航局在江顺大桥施工中,把保护西江 水质作为头等大事。采用超高桩基护筒、封闭循环系 统、岸上泥浆沉淀池和全封闭爬模处理等方法,确保6 万余立方米的钻孔泥浆和数十吨的建筑垃圾丝毫没有 掉落西江水面。并在钢箱梁中铺设排水管道,不仅能 将桥面施工中产生的污水引到岸上集中处理,还能有 效防止大桥在运营中出现桥面污水或油料渗漏等污染 事故,开创了国内桥梁环保建设的先河。

Persistence on Environment Governance

On environment governance, CREC embodied the harmony of man and nature into every project, established the top-to-bottom and all-around monitoring green environmental protection management system and actively implemented the ecological environment protection work. Each project department of the company insisted on "construction of excellent quality projects, creation of civilized ecology " principle, implemented company's high standard environmental protection and soil conservation measures and regarded "project quality and double excellence of environmental protection and water conservation " as its goal to strive to achieve the high degree of harmony and unity between excellent quality project and beautiful environment.

Information 1: CREC No.1 actively developed sewage treatment and other water protection business. It established water companies in Lanzhou, Yinchuan and Maanshan and the daily sewage treatmentcapacity of Maanshan CREC Water Company reaches 100,000 tons, which undertakes 50% of sewage emission reductions of Maanshan City.

Information 2: CREC No.5 paid high attention to environmental management of operational projects such as Lasa-Shigatse, Guiyang-Guangzhou and Hangzhou-Changsha Railways and ensured integration with surrounding environments. In Aug 2014, it organized 130 people in Sining to carry out "cleaning for better environment" voluntary labor activity. A total construction area of 220,000 m² has been cleared and 22 trucks (over 600 tons) of garbage have been shipped.

Information 3: During the construction of Jiangshun Bridge, CRPCEC prioritized the protection of Xijiang River. It adopted methods such as super-high pile foundation casing, closed cycle system, mud sedimentation basin on shore and totally closed creeping formwork to make sure that 60,000 m³ drilling mud and tons of construction wastedidn't fall on the surface of Xijiang River. It also laid drainage pipeline in the steel box beam, which can not only lead sewage created during bridge floor construction to the shore for centralized treatment, but also effectively prevent bridge floor sewage, oil plants leakage and other pollution incidents during the operation of the Bridge. This is a significant precedent in environmental protection of domestic bridge construction.

中国中铁始终致力于生态环境的保护工作,工程开工 前,均组织专业人士认真进行生态环境保护方面的评 估,制定切实有效的保护方案,特别是针对生态易受 扰的作业施工场区,开展水土保持、生物多样性保护、 植被保护等工作,做到生态环境与工程建设同步规划, 同步实施。施工过程中增加生态保护的投入,使用环 保设备、改进施工工艺和优化施工方案,减少对水、 大气、植被和生物的影响。全年未发生生态环境事件。

资料 1:2014年,中铁三局沪昆客专云南段 TJ4 标段 项目部积极开展建设临时用地复垦工作。在施工结束 后,及时把事先剥离的熟土回填至复垦区内,并修建 复垦区排灌系统,完成复垦土地 300 亩,并办理了《临 时用地复垦土地移交书》,受到当地政府和业主的表扬。

资料 2:中铁上海局大西客运专线采用湿地泥浆回用 技术和泥浆分离系统,尽可能降低泥浆中的固体含量, 分离后再次利用,既有效解决了湿地泥浆排放问题, 又大量减少了固体废物的排放,减少了建设临时用地 面积,减少了湿地的破坏,达到保护生态环境的目的。

Protection of Natural Ecology

CREC has always committed to the ecological environment protection, before the project starting, CREC always organized professional personnel to evaluate the ecological environmental protection situations carefully, formulized practical and effective protection program, developed works such as conservation of water and soil, biodiversity protection, vegetation protection etc. especially focusing on ecology in job execution site that liable to be disturbed, planed and implemented the ecological environment with the project construction synchronously. In the construction progress, CREC increased the investment in ecological protection, applied environmental protection environmental equipments, improved ecological processes and optimized construction program, thus reduced the impact on water, gas, vegetation and live beings. No ecological destruction occurred throughout the year.

Equipment 1: In 2014, CREC No.3 Shanghai-Kunming High-Speed Railway Yunnan Section TJ4 Section Project Department actively conducted the construction of temporary ground reclamation. After construction, it timely backfilled mellow soil that removed earlier back to the reclamation area, constructed irrigation and drainage system in the reclamation area, completed reclamation of 300-Mu lands and handled Transfer Notice of Temporary Ground Reclamation Land, which received compliments from local government and owners.

Information 2: CREC Shanghai Bureau Datong-Xi'an High-Speed Railway adopted wetland mud recycling technology and mud separation system, which greatly reduced solid content in mud and allowed it to be recycled after separation. It not only solved the discharge problem of wetland mud, but also greatly reduced the discharge of solid waste, the construction area of temporary ground and destruction on wetland and reached the goal of ecological environment preservation.

中国中铁高度重视员工权益保护,坚持男女平等,依 法签订劳动合同,建立科学的薪酬管理制度,维护职 工合法权益。

劳动合同管理

2014年,公司认真贯彻落实新修订的《劳动合同法》, 员工劳动合同签订率达到100%。认真贯彻落实国家 有关劳务派遣用工的法律法规,积极采取"四个一 批"措施("清理一批、改造一批、培养一批、转录一 批"),严格规范企业劳务派遣用工管理,有效维护企 业劳务派遣员工的切身权益。

员工薪酬管理

中国中铁建立了员工工资正常增长和保障机制,稳步提高员工收入水平。2014年,公司研究制定了《职工工资按时足额发放与企业负责人年薪挂钩的补充意见》,建立了职工工资风险预警拖欠信息体系。全年支付员工工资总额243.5亿元,较上年增长10.2%。

员工社保管理

公司切实保障职工合法社保权益,督促成员企业及时 为职工参加基本养老保险、基本医疗保险、工伤保 险、失业保险及生育保险。积极贯彻落实国家关于行 业、企业社会保险纳入地方管理的要求。

员工民主权利

2014年,公司召开一届五次职代会,由工会代表全体员工与企业签订了《中国中铁2014年集体合同》;坚持职代会审议行政工作报告、民主评议领导人员、职工提案报告等制度,进一步畅通了职工民主参与、民主管理、民主监督的渠道。修订出台《工程项目部厂务公开实施办法》,从源头维护了员工的合法权益。

员工生活保障

2014年,全公司继续深化"三不让"帮扶救助工作, 积极为困难员工排忧解难,全年共检据报销使用专项 资金4983万元,帮助困难员工、农民工3.18万人次。 "两节"期间,筹措送温暖资金1.2亿元,慰问员工、 离退休人员、一线员工和农民工25万余人。

员工休假制度

公司严格遵守国家劳动法律法规,认真执行国家《员 工带薪年休假条例》及其他各类假期规定。对在法定 节假日、公休假日工作和延长工作时间的职工,按照 国家法律规定支付薪酬及加班工资。

Maintenance of Staff's Rights and Interests

CREC paid high attention to maintenance of staff's rights and interests and supported gender equality. Through the agreement and signature of labor contract according to law, it established a scientific system of salary management and maintained the legal rights and interests of staff.

Labor Contract Management

In 2014, the company strictly implemented the newly revisedLabor Contract Law, with signature rate of labor contract in the whole company reached 100%. It strictly implemented national laws and regulations with regard to labor dispatching and employment, actively adopted"Four Batches" measure ("clear a batch, remold a batch, cultivate a batch and transfer a batch"), strictly regulated enterprise management on labor dispatching and employment and effectively protected the personal rights of outsourcing laborers.

Salary Management for Staff

CREC built regular employee income increase mechanism and security mechanism and raised income of the employees gradually. In 2014, the company studied and formulated Supplementary Opinions on Linking the Annual Salary of Enterprise Executives with Paying Staff Salaries on Time and in Full and established Staff Salaries Delinquency Risk Warning Information System. During the whole year, the total sum of paid salaries is 24.35 billion Yuan, with year-on-year growth of 10.2%.

Social Insurance Management for Staff

The company protected employees' legal rights of social insurance and urged member enterprises to cover employees'basic endowment insurance, basic medical insurance, work-related injury insurance, unemployment insurance and maternity insurance. It actively implemented national requirements on industry and enterprise social insurance being incorporated into local governance.

Democratic Rights of Staff

In 2014, the company held the 5th session of the first staff's congress. On the congress, union representative staff signed CREC 2014 Collective Contract with the Administrative Department; it insisted on administration work report reviewed by workers' congress, democratic appraisal of leaders, staff proposal report and other system and further smoothed the channel of democratic participation, democratic management and democratic supervision. It revised and issued Implementation Measures of Factory Affairs Publicity of Engineering Project Department and protected employees' legal right at the source.

Life Guarantee for Staff

In 2014, the whole company further deepened the "three prevention" assistance and relief works and actively helped employees with difficulties. It totally inspected and reimbursed special fund over RMB 49.83 million Yuan in the whole year and helped over 31,800 staff in difficulty and migrant workers. During the "Two Festivals" Period, the company raised warm-delivery fund of RMB 120 million Yuan, visited over 250,000 staff, retirees, first-line staff and migrant workers.

Holiday System for Staff

The company strictly complied with the national labor legal regulations, carefully implemented the national Regulations on Staff Paid Annual Leave for Employees and various other holiday regulations, paid remuneration and overtime salary to staff that worked on legal holidays, public holiday or work overtime according to national legal regulations.

中国中铁大力实施"人才强企"战略,把人才资源视为企业的第一资源,努力做到人才资源优先开发、人才结构优先调整、人才投入优先保证、人才制度优先创新。

2014年,公司深入推进干部人事制度改革,研究制定 了《领导人员日常履职情况巡察办法(试行)》,首次建 立了对二级企业领导班子成员特别是主要领导的日常监 督管理机制。研究制定了《股份公司片区督导巡视工 作实施办法》,根据全国工程项目区域分布情况成立了 8个督导巡视组,强化了股份公司对生产一线的管控能 力。制定了《股份公司职业项目经理管理办法(试行)》, 畅通了项目经理职业发展通道。组织开展了职业项目 经理首次认定工作,全公司在岗的5563名项目经理全 部参加并通过了工程项目精细化管理知识考试,其中有 4336人被认定为四级或五级职业项目经理,为深入推 进项目经理职业化建设打下良好基础。

2014年,公司对首次评选认定的 6 名中国中铁专家进行了聘期考核,同时增补了 34 名中国中铁专家。公司 共培养出全国重点领域创新团队 1 个、第五届全国专 业技术人才先进集体 1 个,全国专业技术人才先进个 人 1 人,新世纪百千万人才工程国家级人选和国家有 突出贡献中青年专家 2 人,詹天佑铁道科学技术奖 8 人, 国务院政府特殊津贴获得者 24 人,共评审通过教授级 高工 170 人、高级工程师 1887 人、高级经济师 226 人、 高级会计师 110 人。

2014年,全公司共投入技能人才培训费用 7964 万元, 举办技能培训班近 2000 班次,培训 24 万人次,促进 了人才队伍能力素质的大幅度提高。

资料:2014年,公司高技能人才工作取得丰硕成果, 培育出全国技术能手2人,中央企业技术能手9人,全 国青年岗位能手9人;国家技能人才培育突出贡献单位 1个,国家技能人才培育突出贡献个人1人。有1.3万 多名员工和农民工参加了技能鉴定和高技能人才评价, 共计鉴定评价合格1.1万多人,其中评审通过技师2046 人,高级技师963人。

Promotion of Staff's Growth

CREC strongly implemented the "Talent Enterprise" strategy, promoted the enterprise development through talents development, treated the talents as the first enterprise recourse, made effort to prior explore the talents resources, prior adjust the talents structure, prior ensure the talent investment and prior innovate the talents system.

In 2014, the company further promoted cadre and personnel system reform, formulated Daily Performance Patrol of Leaders (Trial) and for the first time, established daily supervision management mechanism on leading members of secondary enterprises, especially on key members. It formulated Implementation Measures of Inspection Touring of the Company's Regional Supervisors, established 8 supervisor inspection groups according to the distribution of national projects and strengthened the company's capacity of management and control on production line. It also formulated The Company's Management Measures on Professional Project Managers (Trial) and smoothed the career development channel of project managers. It organized and carried out first affirmation work of professional project managers. 5563 project managers of the whole company attended and passed engineering project delicacy management test, with 4336 of them being considered as Level 4 or Level 5 professional project managers, which set a solid foundation for deep promotion of the career construction of project managers.

In 2014, the company appraised and selected 6 CREC experts for employment term assessment for the first time and added 34 CREC experts. The company totally cultivated 1 national innovation team on key fields, 1 advanced collective of the 5th national professional and technical personnel, 1 advanced individual of national professional and technical personnel, 2 people selected for New Century Talents Project and young and middle-aged expert made outstanding contributions for the country, 8 Zhan Tianyou Railway Science and Technology Awards and 24 winners of the State Councilspecial government allowance. The company totally approved 170 professor senior technicians, 1887 senior engineers, 226 senior economists and 110 senior accountants.

In 2014, the whole company has totally invested 79.64 million Yuan for skilled talents training, hosted about 2000 skill training courses, trained over 240,000 talents and promoted the substantially increase the capacity and quality of talent team.

Information: In 2014, the company achieved plentiful and substantial results inhigh-skilled talent works. It cultivated 2 national technical experts, 9 central enterprises technical experts, 9 national young experts, 1 outstanding contribution unit in national skilled talents training and 1 outstanding contribution individual in national skilled talents training. About 13,000 staff and migrant workers participated in skill appraisal and high-skilled talentevaluation. A total number of 11,000 people have passed evaluation, including 2046 technicians and 963 senior technicians.

公司坚持以人为本,认真落实农民工"五同"管理。通 过建立向外协队伍派驻党群工作协理员制度,进一步加 强了对农民工队伍的管理。通过督促劳务分包企业、劳 务派遣公司与劳务人员全部签订劳动合同,并实行备案 管理,维护了农民工权益。通过健全完善农民工专项工 作机制,累计为农民工提供75万个就业岗位,支付农 民工各类报酬351.1亿元。通过健全农民工工资发放监 督机制,采取直接发放或办理工资卡等多种形式,确保 农民工工资按时足额发放。坚持开展农民工职业技能 培训和鉴定工作,培养鉴定农民工3300人,鉴定合格 技师139人,不断提升企业所使用的农民工技能和素 质。将农民工纳入企业组织的各类技能大赛、技术比武 和评先评优,充分调动农民工的工作积极性和创造性。 2014年,2人被评为全国、省市优秀农民工,1人荣获 全国"五一劳动奖章"。

资料 1:2014 年,公司积极打造"中国中铁关爱农民 工公益行动"社会责任新品牌。动员员工和家属为农民 工捐献家庭闲置衣物,同时从其他院校、部队、社区等 也募集了大量衣服;经过志愿者分类整理、清洁消毒 后,以 1-5 元的"象征性价格"义卖给北京地区各工程 项目的农民工;销售所得款项,通过有关部委捐赠给公 益事业。活动开展一年来共募集、义卖衣物 12960 余 件,惠及农民工 5600 余人。活动得到了新华社、新浪网、 凤凰网、中国新闻网等媒体的关注和报道,先后荣获"首 都学雷锋志愿服务站"、"地球站公益创业工程最佳组织 奖"、"首届中国青年志愿服务项目大赛银奖"、"中央企 业优秀志愿服务项目"等诸多荣誉。

Implementation of "Five Same" Management

The company stuck to the principle of "people first" and implemented "Five Same" Management for peasant workers. By establishing party-masses work assistant system for outsource team, the company further strengthened administration of peasant workers. By urging labor subcontracting enterprises and labor dispatching companies to sign labor contracts with workers, the company carried out record management and protected rights of peasant workers. By improving special work mechanism for peasant workers, the company provided jobs to 750,000 peasant workers accumulatively and paid wages to them totaling 35.11 billion Yuan. By improving peasant worker wage payment supervision system, the company paid wages to peasant workers on time in full through many different ways including direct payment and wage card. Moreover, the company kept carrying out vocational training and appraisal activities for peasant workers, fostered 3300 gualified peasant workers and 139 qualified technicians from them and gradually enhanced skills and guality of the peasant workers. It included peasant workers into all kinds of skill competitions, technological competitions and wok appraisal activities organized by the company. In 2014, two people were honored national, provincial and municipal "Excellent Peasant Workers". One peasant worker won "National May 1st Labor Medal".

Information 1: In 2014, The company actively created the new brand for social responsibility "CREC Public Welfare for Migrant Workers". Staff and their family members are encouraged to donate their unused clothes to migrant workers. A large amount of clothes is also collected from other colleges, armies and communities. After sorted, cleaned and disinfected by volunteers, the clothes will be sold to migrant workers from the engineering projects of Beijing at a token price of 1-5 RMB. The sales proceeds will be donated to public welfare by the relevant ministry and commission. In the past one year after the activity was developed, more than 12,960 pieces of clothes have been collected and sold for charity, which benefited above 5,600 migrant workers. The activity was concerned and reported by public media of Xinhua News, Sina, Ifeng and China News, and has been awarded with numerous honors like "Beijing Leifeng Volunteer Service Station", "The Best for Organizing Earth Station Social Entrepreneurship Project", Silver Award of "The 1st Contest for China Youth Volunteer Service", "Excellent Central Enterprise for Volunteer Service" and so on.

Information 2: China Railway Tunnel Group strictly implemented "Five Same" management, provided employment for more than 100,000 peasant works during the whole year and offered them two career development channels: technology and management.

资料2:2014年,中铁八局结合夏季施工酷暑、高温 等实际,广泛开展为施工一线送清凉活动,共计筹 集慰问资金391万元,慰问项目部253个,慰问职工 11156人次、农民工39232人次,切实保障了一线职工 清凉度夏。

Reinforcement of Three Projects Construction

In 2014, CREC adhered to the "three projects" construction with main content of construction site life, culture and hygiene, accumulatively invested RMB 244 million Yuan in the "three project' construction, fully improved the standard of living, culture and hygiene in forefront of the construction and created good living and working environment for worker at the production line.

Information 1: in 2014, the company union granted 5.41 million Yuan for Three Projects Construction, including 1 million Yuan to Venezuela Railways, Ethiopia Railways and Congo overseas projects. It provided special fund of 400,000 Yuan for the prevention and control Ebola for projects under construction in Africa, which further improved working, living and cultural conditions and environment for employees.

Information 2: in 2014, considering the intense heat of summer construction, CREC No. 8 extensively carried out activities to bring coolness to the construction frontline. It collected sympathy fund of 3.91 million Yuan and visited 253 project departments, 11156 employees and 39232 peasant workers, which allowed frontline workers to spent summer with less heat.

多年来,中国中铁在一系列重大自然灾害面前挺身而出, 勇挑重担,积极投身抢险救灾,积极践行央企责任,受到 各级政府和社会各界好评。

2014年,全公司积极参与各地各类抢险救灾近300次,投 入抢险救灾人员近2万人次、设备3000多台套、投入资金 近6000万元。其中,所属昆明国家铁路隧道抢险救援基地 先后6次参与国家重大抢险救灾工作,成功救出被困人员45 人,救助受灾群众100余人,成为国家抢险救援的重要专业 力量。此外,由所属中铁五局和中铁隧道局分别负责组建 的铁路隧道专业抢险救援队伍也已在贵阳和西安完成了基 地建设、机构设置、规章制度建设、设备订购等工作,到 位的救援人员已开展业务培训。

资料1:在川黔线泥石流抢险中,中铁一局投入抢险人力 1780人、资金386万元、大型机械设备30多台,连续奋战 72小时完成了抢险任务。

资料2:2014年8月3日,云南鲁甸发生6.5级地震,中国中 铁紧急组织所属中铁一局、二局、大桥局、隧道局、上海 局等单位,成立多只抢险队伍,投入大量大型机械设备, 投身抢险救援工作,清除道路塌方,打通运输通道,为抗 震救灾提供物资和人员援助保障。

资料3:2014年7月,受吉林省白城市团结水库洪水漫堤影响, 乌白铁路桥梁被洪水冲毁, 行车中断。中铁九局迅速 调集380余名抢险人员和近20台大型机械、车辆投入抢修。 经过连续50小时的昼夜奋战, 圆满完成了抢修任务, 使乌 白线比原计划提前4个小时通车。

Disaster Relief

For years, CREC has come out bodily, worked in the first line, and dared tochallenge when facing series of serious natural damages, actively took partin the rescue works; actively fulfilled the responsibility of central enterprise, and has been highly praised by both the governmentand public.

In 2014, the company actively participated in rescue and relief works for about 300 times, with the investment of nearly 20,000 rescue personnel, 3000 sets of equipment and 60 million Yuan capital. It established national railway and tunnel emergency rescue base in Kunming, involved in 6 national severe rescue and relief works, successfully saved 45 trapped people, helped more than 100 people afflicted by the disaster and became a significant professional force of national emergency rescue. Moreover, railway and tunnel emergency rescue teams established by CREC No.5 and China Railway Tunnel Bureau have completed base construction, institutional setting, rules and regulations establishment and equipment ordering in Guiyang and Xi'an respectively and the rescue workers in place have received operation training.

Information 1: During the debris flowrescue of Sichuan-Guiyang Railway, CREC No.1 put into 1780 people, 3.86 million Yuan capital and 30 large machines and worked 72 hours in a row to complete rescue tasks.

Information 2: On Aug 3, 2014, a 6.5 magnitude earthquake struck Ludian, Yunnan. CREC immediately organized CREC No.1, CREC No.2, MBEC, Tunnel Bureau and Shanghai Bureau to form several rescue teams with many large-scale mechanical equipment. They were devoted into rescue operation and road collapse clearing, opened transport paths and provided supplies and staff assistance guarantee for earthquake relief works.

Information 3: in Jul 2014, being affected by flood water overflow of Tuanjie Reservoir in Baicheng, Jilin Province, Wubai Railway Bridge was destroyed by flood and traffic was interrupted. CREC No.9 quickly organized 380 rescue workers and nearly 20 large machines and vehicles for emergency maintenance. After working 50 hours non-stop, the rescue works have been completed and Wubai Railway was open to traffic 4 hours before the planned time.

Assistance for the Poor

2014年,根据国务院扶贫办有关安排,公司继续选派 3名年轻干部分别到湖南汝城、桂东和山西保德等三个 国家级贫困县挂职,全年一共投入300万元用于改善当 地学习教育和生活条件。公司被国务院扶贫开发领导 小组授予"定点扶贫先进集体"称号。公司积极参与 了由中国扶贫基金会主办的"圆梦832"贫困高中生关 爱行动。

2014年,公司援藏干部李少林被评为"全国对口支援 西藏先进个人"。按照中组部、人社部要求,继续选 派两名同志作为第八批援疆干部到新疆挂职,支援新 疆建设。同时,按照国务院国资委要求,接收一名西 藏国有企业干部到公司挂职锻炼。

资料1:2014年,公司捐资10万元,委托中国扶贫基金 会在保德县成立"中国中铁•新长城自强班",资助家 境困难、品学兼优的50名学生完成高中学业;捐资90 万元支援保德县袁家里养羊项目建设,通过成立专业 合作社组织实施,建立农业示范园,取得良好成效, 得到当地群众一致好评;保德县与中国中铁所属郑州 铁路技师学院签订了合作办学的框架协议。

资料2:中铁信托与四川省慈善总会合作,成立了"中铁信托爱心基金",每年组织实施一批捐赠助老、助教、助学等慈善公益项目。该基金成立两年来,已募集资金270多万元,使用善款120万元。其中,2014年投入善款30万元实施了成都市青羊区西御河夕阳汇居家养老服务项目;向云南鲁甸地震灾区提供紧急捐款援助20万元。

According to related arrangement of the State Council Leading Group Office of Poverty Alleviation and Development, in 2014, the company continued to select 3 young cadres to take temporary posts in nationallevel poverty-stricken counties, including Rucheng and Guidong in Hunan and Baode in Shanxi. In this year, the company invested 3 million Yuan to improve local education and living conditions, which won the title of "advanced collective in fixed-point poverty alleviation" awarded by the State Council Leading Group Office of Poverty Alleviation and Development. The company also participated in "Dream Fulfillment 832" activity sponsored by CFPA, which cares high school students in poverty.

In 2014, Li Shaolin, the company cadres who was sent to support Tibet was awarded "advanced individual of national pairingassistance to Tibet". According to the requirement of the Organization Department of the Central Committee of the CPC and Ministry of Human Resources and Social Security of P.R.C, the company continued to select two people as the 8th batch of Xinjiang assistance cadres to taketemporary posts in Xinjiang and support the construction off Xinjiang. Meanwhile, according to the requirement of SASAC, the company received one Tibetan cadre from state-owned enterprise to take a temporary post in the company for practice.

Information 1: In 2014, the company donated 100,000 Yuan, delegated CFPA to set up "CREC New Great Wall Self-improvement Class" in Baode County and supported 50 excellent students in poverty to complete high school study; it also donated 900,000 Yuan to support raising-sheep-at-home project in Baode County. By setting up specialized cooperatives, it established Agriculture Demonstration Park, achieved good results and received good reputations from local people; Baode County and Zhengzhou Railway Technician College that affiliated to CREC signed framework agreement on cooperative education.

Information 2: China Railway Trust and Sichuan Charity Federation cooperated to establish "China Railway Trust Charity Fund" and organized a number of charity events to support the old, teaching and education. Since its establishment for 2 years, it has raised fund of 2.7 million Yuan and donated 1.2 million Yuan, among which in 2014, it donated 300,000 Yuan to carry out home care series for the old in Xiyanghui, Xiyuhe, Qingyang District, Chengdu; it donated 200,000 Yuan to earthquake stricken area in Ludian, Yunnan for emergency rescue.

2014年,全公司共组建了800多支志愿服务队,投入 志愿服务1.6万多人次,开展各类志愿服务活动1300多 次,大力弘扬社会道德风尚,积极构建和谐社会。

2014年,全公司捐资助学5600多万元,帮扶学生近1万人,支持教育机构资金3000余万元;其他公益慈善事业投入超过300万元。

资料1:中铁大桥局积极推动志愿活动常态化,2014 年,先后开展义务植树、"学雷锋、暖人心"主题捐 赠、"放飞梦想,春满校园"爱心助学、"环保青奥 我先行"等志愿服务活动122次。中铁大桥局青年志愿 服务队被湖北省授予"荆楚学雷锋示范团队"称号。

资料2:2014年,中铁电气化局积极参与秦岭地区的 "驴友"遇险救援工作。全年共配合地方政府完成救援近20次,救援游客23名。

资料3:中铁武汉电气化局一公司襄阳义工小组自2008 年成立以来,坚持六年不间断地对襄樊附近的山区留 守儿童和孤儿进行定向帮扶。2014年,他们共帮扶贫 困留守学生18人和孤儿1人。



资料:2014年,公司制定了《股份公司人才引进管理 办法(试行)》,进一步规范了公司人才引进工作。 四季度,公司成立了4个招聘工作组,组织所属二级企 业赴清华大学、北京大学及重点铁路院校开展了校园 集中招聘工作,通过招聘工作统一宣讲、招聘流程统 一发布、应聘人选集体票决、招聘结果统一公布等环 节,做到了招聘程序公开、竞聘公平、结果公正,确 保一大批高素质的大学毕业生充实到企业。

Promotion of Employment

CREC always regards performance of employment responsibility as a key item in social responsibilities of the company. In 2014, it implemented Collective Contract mechanism, performed their promise on employment, took all possible measures to promote re-employment of laid-off workers and made sure that work rate of the employees of the company kept above 85%. The company created and provided a great number of work opportunities for the society in many different ways, such as recruiting the graduate from colleges and technical secondary schools and demobilized soldiers and recruiting personnel from the talent market. In 2014, the company recruited over 7600 students who just graduated from colleges and technical secondary schools. Demobilized army leader arrangement work in Beijing was acknowledged by the Military Conversion Office of the State Council.

Information: in 2014, the company formulated Regulations on Talent Introduction of the Company (Trial) and further specified the company's talent introduction works. In the fourth quarter, the company established 4 recruitment teams and organized affiliated Level-2 enterprises to Tsinghua University, Peking University and key railway colleges for campus recruitment. By implementing links such asrecruitment talk, recruitment process release, collective vote of candidates, recruitment result announcement, it was made sure that the recruitment process is public, the competition and result is fair and a large number of high-quality graduates are introduced to enterprises.

2014年,公司在全球69个国家和地区开展境外工程项 目设计、施工和产品加工出口业务。目前,在59个国 家和地区有境外在建工程项目364个,涉及铁路、公 路、桥梁、隧道、房屋建筑、城市轨道、市政工程、 农田水利、港口建设等领域;分布于南美、东欧、非 洲、南太平洋、东南亚、中东等地区;公司高锰钢道 岔及钢结构等加工产品远销美国、韩国、丹麦、新西 兰、香港、莫桑比克、孟加拉、澳大利亚、越南、印 度尼西亚、泰国、埃塞俄比亚、尼日利亚、马来西 亚、塞拉利昂、印度、坦桑尼亚、土耳其、老挝等19 个国家和地区。

另外,公司在境外还投资兴办了马里纺织厂、科特迪瓦 制药公司,在南非进行了房地产开发,在刚果金等非洲 地区还开展了以矿产资源交换基础设施工程等业务。

In 2014, CREC achieved overseas revenue of 27.02 billion Yuan.

In 2014, the company carried out overseas engineering project design, construction and product processing and export business in 69 countries and regions over the world. So far, it has 364 overseas construction projects in process in 59 countries and regions, covering areas of railways, highways, bridges, tunnels, housing construction, urban rail, municipal engineering, irrigation and water conservancy and port construction. The projects are located in South America, Eastern Europe, Africa, the South Pacific, Southeast Asia and Middle East. High manganese steel rail, steel structure and other processing products have been sold to 19 countries and regions, including the U.S., South Korea, Denmark, New Zealand, Hong Kong, Mozambique, Bangladesh, Australia, Vietnam, Indonesia, Thailand, Ethiopia, Nigeria, Malaysia, Sierra Leone, India, Tanzania, Turkey and Laos.

Moreover, the company has invested to establishtextile mill in Mali and pharmaceuticals in Ivory Coast. It also conducted real estate development in South Africa and infrastructure engineering projects in Democratic Republic of the Congo and other African countries in exchange formineral resources. 股份有限公司

Global Cooperation

In 2014, CREC signed strategic cooperation agreement and capital increase agreement with Guoxin International Investment Co., Ltd. and co-established overseas project investment platform. After careful assessment and screening, both parties have confirmed 6 relatively mature overseas investment projects. So far, projects approval and review of 3 projects including industrial park in Tanzania and hydropower station in Guyana have been completed.

Information 1: In 2014, CREC has cooperated with Nyerere Foundationof Tanzania and International Finance Corporation to invest in the Nyerere Foundation Building Project and the foundation stone laying ceremony was completed in Dar-es-Salaam, Tanzania.

Information 2: In 2014, CREC carried out many cooperative projects with governments of Ethiopia, Chad, Mali, Indonesia, SHIKUNBINUI Group of Israel, SYSTRA of France and other international corporations.

Especially in recent 10 years, during the process of outsourcing foreign projects, CREC subsidiaries not only offered quality engineering projects that are favorable to the people, improved capacity of local transportation, improved people's living conditions, speeded economic and trade contact among host countries and surrounding countries and promoted prosperity and development of local economy, but also actively provided employment opportunities for local people. In 2014, the company's overseas projects have hired 450,000 local people.

Information: CREC and Ethiopian government carried out deep cooperation and adopted Chinese railway design and construction standard for the first time in the construction of Addis Ababa-Djibouti railway; after completing the construction tasks of Addis Ababa light rail project, CREC will continue to provide operation maintenance and management service for Ethiopia.

Information 1: In Sep 2014, Ebola outbreak was found in Sierra Leone. CREC actively undertook the transportation of supplies from China in Sierra Leone. The company staff focused on the overall situation, protected themselves and worked 3 days non-stop without worrying about the epidemic situation. They completed the transportation task in time and made positive contribution in fighting against Ebola.

Information 2: In 2014, CREC No.10 North Venezuela Railway Project Department and FMO Project Department helped local communities to improve infrastructure construction. They have remolded, repaired and paved roads of more than 60 km, expanded a hospital in Ordaz, reformed and repaired 4 schools and offered and installed 24 air conditioners for local schools for free, which received good reputation from local citizens.
